CONSTRUCTION, ORGANIZATION AND MAJOR COMMITTEES:

1. Constructed the first Renal Unit in Sudan, at Soba University Hospital, Khartoum 1975. In this unit, regular hemodialysis was started for the first time in Sudan. Intermittent Peritoneal Dialysis (IPD) was also established for Acute Kidney Injury (AKI), known then as Acute Renal Failure (ARF). The very first kidney transplant from a live donor in Africa was carried out in the Soba University Hospital in 1976. It is interesting that both the patient and donating son came over from Saudi Arabia to Sudan to have the operation performed at Soba University Hospital. The late Professor Omar Beliel was the transplantation surgeon and I was the nephrologist who took care of the patient from the medical perspective.
2. Constructed and chaired the new Medical Unit at Soba University Hospital, Khartoum, 1976. This unit went hand in hand with the Renal Unit at the same hospital, and still goes on.
3. Moved to Saudi Arabia in 1977 and was asked to establish a Kidney Unit in the University Hospital at Riyadh, Saudi Arabia. With the help of many other colleagues the “Renal Unit at

King Khalid University Hospital, Riyadh” was established in 1977 - 1983.

4. Started a program for Continuous Ambulatory Peritoneal Dialysis (CAPD) for the first time in Saudi Arabia at the King Khalid University Hospital, Riyadh, Saudi Arabia in 1982. This was the program that promoted CAPD in Saudi Arabia and other Arabian Countries, and trained many leaders in this field. Later on Automated Peritoneal Dialysis (APD) was added on to CAPD in many centers in Saudi Arabia.
5. Moved back to Sudan in 2003 and joined the National Ribat University Hospital, Khartoum. There was a need to establish a dialysis unit at that hospital so a new dialysis and nephrology service was established under my leadership in 2003-2004.
6. Appointed as a Founding President (Rector) to a new university at Khartoum named “Al-Mughtaribeen University” in 2010. This is a joint venture between the “League of Sudanese Working Abroad” and the Fedral Council of Ministers, Khartoum. The new university was established with the aim of providing university education for the children of the Sudanese Diaspora. The university provides Bachelor degrees in twelve disciplines in Health Sciences, Engineering, Business Administration and Arts.
7. Chaired the committee that started the Sudan Nephrology Fellowship, as an off-shoot of the “Sudan Medical Specialization Board” in 2004. Since then the “Nephrology Fellowship Program” has flourished and now graduates about 10-15 fellows in Nephrology every year. Many of the graduates of this program are working in Sudan and other countries in renal and dialysis units.
8. Chairman of the “Circle of Applied Sciences” (دائرة العلوم التطبيقية) in the Sudan “Islamic Fiqh Academy” (مجمع الفقه الإسلامي) 2005-to- 2019. This is the official National Institute that deals with ethical issues and queries pertaining to science applications in modern life.
